## **Review Items**



The financial report and updated bill list for August 2023 was reviewed and discussed. Sandra McCarthy made a motion to approve payment of the August 2023 bill list. Cheryl Neu seconded the motion. Approved unanimously (5-0). The checks were signed by Rodger Shaddy and Cheryl Neu.

President Tim Sanders read aloud the following report for the record.

Illegal Water Connection: The Carson Street water use issue has not been resolved and is still under investigation.

PFAS Grant: Jamie Porter is submitting documents to apply for PFAS grant funding. He brought documents relating to these for President Tim Sanders to sign. The papers were signed and no other Board action is required at this time.

Personnel Update: The job requirements language used in advertising for Operations and Maintenance Personnel needs to be updated. Language should reflect that water operators use chemicals in the process to create drinking water, and need to be free from the influence of drugs and alcohol.

Jamie Porter turned the floor back to President Sanders.

President Sanders announced the next meeting will be October 12, 2023 and asked for a motion to adjourn if there was no further business.

Sandra McCarthy made a motion to adjourn. Rodger Shaddy seconded the motion. Approved by unanimous vote (5-0).
