CUSTOMER NEWSLETTER – JANUARY 2023

This month we share some background information on some of the connections we have, both internally and externally, that provide our organizational structure and allow us to add value to our customers and the region.

BOARD OF COMMISSIONERS

Rainbow is governed by a five-member volunteer Board of Commissioners. Board members are elected in odd-numbered years to a four-year term of office, selected from registered voters residing within the District. Rainbow's Board meets monthly to manage finances and adopt the policies that guide the staff and govern the District's customers.

BUDGET COMMITTEE

Rainbow's Budget Committee consists of the five Board Members, plus five additional electors that are appointed by the Board to a three-year term of office. (Electors are registered voters residing within the District). **We currently have one vacancy on our Budget Committee.**

To serve on the Budget Committee you need to be a district customer, an eligible voter, and attend a minimum of two evening meetings. This year the meetings are at 5:30 pm on April 12 and May 10. Previous public budgeting experience is helpful but not required. LANE COUNCIL OF GOVERNMENTS (LCOG)

Rainbow Water District is a member of the Lane Council of Governments, a voluntary association of local governments in Lane County working together to adopt policies and coordinate planning and technology at the regional level. A member of Rainbow's Board is also appointed to serve on LCOG's Board of Directors along with other representatives from over thirty member agencies.


OREGON WATER/WASTEWATER AGENCY RESPONSE NETWORK (ORWARN)

Beyond our regional partnerships with EWEB and SUB, and the small neighboring water systems we support, Rainbow is a member of the statewide ORWARN. This group is composed of member utilities providing voluntary assistance to each other during an emergency incident. Since emergencies may transcend jurisdictional boundaries, effective coordination and sharing of resources is essential in preserving lives and property. We are proud to make ourselves available to help others in need with the limited resources (staff and equipment) that we are able to share, and we are comforted knowing that others have our back should we need assistance.

Additional meetings are rare but may be called if needed. Members are responsible to review documents on their own time, then will discuss and vote on proposals at our public meetings.
